

This report provides key demographic and economic data for Illinois Congressional District 11. It is made available by the Chicago Cook Workforce Partnership, DuPage Workforce Board, River Valley Workforce Investment Board, and Workforce Investment Board of Will County.¹

At A Glance

- The Congressional District's current population of 1,195,963 is expected to increase by 87,834 over the next ten years.
- By 2017, this Congressional District is projected to create 39,440 **new jobs** with positions in sales and related occupations and business and financial operations representing the largest numbers of new jobs.
- The Congressional District's largest industry sector of employment is retail trade followed by the healthcare and social assistance industry.


Population

• While the distribution of the Congressional District's population is similar to the State's population, the District's under 20 years age group is a much higher than representation of this age group statewide. Also, the older population (65 years and over) is underrepresented when compared to representation statewide.

¹Data in this report has been compiled at the zip code level. In an effort not to skew district data, zip code areas representing less than 10,000 acres in the Congressional District have been excluded from the district's data. Exceptions include data for zip codes 60604, 60602, and 60301 which were included in Congressional District 7 and zip code 60537 which was included in both Congressional District 14 and 16 data.



Industry Sector Employment

Between 2007 and 2012

- The Congressional District gained 4,455 jobs during the past 5 years while the State lost 106,433 jobs overall.
- The industry sectors gaining the most jobs over the past 5 years were healthcare and social assistance (10,177) and finance and insurance (3,762).
- Industry sectors with the largest job loss between 2007 and 2012 were construction (-11,814) and administrative/support/waste management/remediation services (-5,005).



Looking Forward to 2017

- Over the next five years the 11th Congressional District is expected to gain 39,440 jobs with jobs projected to grow at a higher rate than the State. The healthcare and social assistance sector is projected to add the largest number of jobs (9,826) followed by profession, scientific and technical services (4,285). Manufacturing is expected to have the greatest job loss (-4,197).
- Retail trade is currently the largest industry sector, with 67,313 jobs and average earnings per worker, with benefits, of \$32,977. It is projected that healthcare and social assistance will become the largest industry of employment by 2017.
- In Congressional District 11, the average earnings per worker, including benefits, is \$51,861, which is lower than the State average of \$53,157.

Occupations

Between 2007 and 2012

- Over the past 5 years, business and financial operations occupations grew the most adding 3,792 jobs at a rate of 11%. The second largest growth was in healthcare practitioners and technical occupations which added 3,635 jobs at a rate of 15%.
- Construction and extraction occupations (-8,838) lost the most jobs during the 5 year period followed by office and administrative support occupations (-4,112) and production occupations (-2,299).
- The largest occupational group in the 11th Congressional District is sales and related occupations with 85,981 jobs followed by office and administrative support occupations with 77,682 jobs.



Looking Forward to 2017

- Over the next 5 years, sales and related occupations are expected to have the largest job growth, adding 5,688 jobs. Business and financial operations occupations are expected to have the second largest gain with 4,097 additional jobs.
- Legal occupations earn the highest average hourly wage of \$43.99 followed by management occupations averaging \$40.31 per hour.
- The highest proportional growth is projected for healthcare support occupations with a 17% increase.
- The largest job loss is expected in production occupations (-1,516) followed by architecture and engineering occupations (-118).


• Retail salespersons and cashier occupations are the two largest occupations in the Congressional District.



In the top ten largest occupations, sales representatives, wholesale and manufacturing (except technical and scientific products) have the highest average hourly wage of \$31.82 followed by heavy and tractor-trailer truck drives at \$20.13 per hour.



 Personal financial advisors and real estate sales agents are expected to be the fastest growing occupations in the Congressional District.

Occupations Requiring Educational Attainment

- In the 11th Congressional District, the largest occupation requiring a postsecondary vocational award or higher is real estate sales agents.
- Four of the largest occupations requiring an educational attainment beyond high school completion are also among the fastest growing occupations: real estate sales agents; registered nurses; personal financial advisors; and securities, commodities, and financial services sales agents.
