

This report provides key demographic and economic data for Illinois Congressional District 14. It is made available by the DuPage Workforce Board, Lake County Workforce Investment Board, McHenry County Workforce Investment Board, River Valley Workforce Investment Board, and Workforce Investment Board of Will County.

At A Glance

- The Congressional District's current population of 1,591,946 is expected to increase by 91,665 over the next ten years.
- By 2017, this Congressional District is projected to create 43,636 **new jobs** with positions in sales and related occupations and business and financial operations representing the largest numbers of new jobs.
- The Congressional District's largest industry sector of employment is government followed by the retail trade industry.


Population

• The proportion of the Congressional District's population under the age of 20, and ages 35-49 years is higher than the proportion of these age groups in the State's total population while the proportion of individuals ages 20-34 years is less than the representation of this age group in the State's population.

In an effort not to skew district data, zip code areas representing less than 10,000 acres in the Congressional District have been excluded from the district's data. Exceptions include data for zip codes 60604, 60602, and 60301 which were included in Congressional District 7 and zip code 60537 which was included in both Congressional District 14 and 16 data.



Industry Sector Employment

Between 2007 and 2012

- The Congressional District lost 12,891 jobs during the past 5 years while the State lost 106,433 jobs overall.
- The industry sectors gaining the most jobs over the past 5 years were finance and insurance (8,640) and healthcare and social assistance (7,645).
- Industry sectors with the largest job loss between 2007 and 2012 were construction (-17,269) and manufacturing (-9,106).


Looking Forward to 2017

- Over the next five years the 14th Congressional District is expected to gain 43,636 jobs with jobs projected to grow at a higher rate than the State. The healthcare and social assistance sector is projected to add the largest number of jobs (10,128) followed by finance and insurance (7,167). Manufacturing is expected to have the greatest job loss (-6,653).
- Government is currently the largest industry sector, with 82,859 jobs and average earnings per worker, with benefits, of \$58,880. This industry is expected to continue to be the District's largest industry through 2017, growing to 86,570 jobs (3,711).
- In Congressional District 14, the average earnings per worker, including benefits, is \$48,235, which is lower than the State average of \$53,157.

Occupations

Between 2007 and 2012

- Over the past 5 years, business and financial operations occupations grew the most adding 5,513 jobs at a rate of 14%. The second largest growth was in education, training and library occupations which added 3,502 jobs at a rate of 9%.
- Construction and extraction occupations (-12,686) lost the most jobs during the 5 year period followed by office and administrative support occupations (-6,297) and production occupations (-5,501).
- The largest occupational group in the 14th Congressional District is sales and related occupations with 104,251 jobs followed by office and administrative support occupations with 83,752 jobs.



Looking Forward to 2017

- Over the next 5 years, sales and related occupations are expected to have the largest job growth, adding 6,903 jobs. Business and financial operations occupations are expected to have the second largest gain with 5,797 additional jobs.
- Legal occupations earn the highest average hourly wage of \$40.52 followed by healthcare practitioners and technical occupations averaging \$36.90 per hour.
- The highest proportional growth is projected for healthcare support occupations with a 16% increase.
- The largest job loss is expected in production occupations (-2,658) followed by construction and extraction occupations (-365).

• Retail salespersons and cashier occupations are the two largest occupations in the Congressional District.



• In the top ten largest occupations, personal financial advisors have the highest average hourly wage of \$24.44 followed by customer service representatives at \$16.34 per hour.



 Personal financial advisors and securities, commodities, and financial service sales agents are expected to be the fastest growing occupations in the Congressional District.





Occupations Requiring Educational Attainment

- In the 14th Congressional District, the largest occupation requiring a postsecondary vocational award or higher is real estate sales agents.
- Five of the largest occupations requiring an educational attainment beyond high school completion are also among the fastest growing occupations: real estate sales agents; personal financial advisors; elementary school teachers (except special education); registered nurses; and securities, commodities, and financial services sales agents.
